3. The original certificates of marks cards, passing certificate and caste certificate should be produce at the time of admission and three sets of Xerox copies be submitted.
4. The fee concession is applicable only to the SC/ST, Category I.
5. The Part Time candidates of SC/ST, Category I & permanent teachers of the affiliated/constituent colleges of Gulbarga University have to pay full fees prescribed for GM Students.
6. Any false information is submitted or information suppressed and found at a later date, the admission of such candidates will be cancelled.
7. The candidates who have applied for both the courses (M.Phil. and Ph.D.) and appear in both the selection list should produce consent letters.
8. Those candidates selected for M.Phil/Ph.D Programme, who are working as Guest Lecturer in University/Government/Private Colleges shall give an undertaking stating that "they shall forego their appointment as Guest Lecturer and continue M.Phil/Ph.D Programme on full time basis".






